Global and Intercultural Engagement Honour

For Western Law students seeking to complete the Global and Intercultural Engagement Honour (GIEH), all requirements must be completed during your JD (or combined JD) degree program. When completed, the Global Honour will be noted on your official Western transcript.

To achieve the Global Honour, students must successfully accumulate a **minimum of 100 points** through four categories:

- <u>Category 1 Academic Course Work:</u> you **must** complete a minimum of 20 points, to a maximum of 50 points.
- <u>Category 2 Global Experience:</u> you **must** complete a minimum of 20 points, to a maximum of 50 points.
- <u>Category 3 Intercultural Training:</u> This category is optional. You may complete a maximum of 50 points.
- <u>Category 4 Language Proficiency:</u> This category is optional. You may complete a maximum of 40 points

Category Information:

1. Academic Coursework – REQUIRED

- 10 points for each one term Law course.
- Requires at least 20 points (a minimum of two approved one-term courses) but no more than 50 points will be accepted for this category.
- See attached list for approved Law courses.

2. Global experience at Home or Abroad – REQUIRED

- Requires at least 20 points but no more than 50 points in this category.
- How points are accumulated:

Global Experience Abroad	Global Experience at Home (volunteering)	Points
1 to 3 consecutive weeks	25 to 70 hours within one term	10 points
4 to 6 consecutive weeks	71 to 140 hours within one term	20 points
7 plus consecutive weeks	141+ hours within one term	30 points

- An exchange term or participation in the Western Law Internship Program (WLIP) both earn 30 points
- Other Western Law opportunities:
 - The Exchange Buddy Program (active participation required)
 - Executive position with a Western Law student organization such as:
 - International Law Association (ILA)
 - French Law Society
 - Canada US Law Institute (CUSLI)
 - LEVEL (formerly Canadian Lawyers Abroad)
 - CLS working with clients in another language (e.g. French or Spanish)
 - Participation through <u>Impact Experience</u> (formerly Alternative Spring Break)
 - Volunteering during Western's International Week
- **Please note:** although course work can be counted retroactively, Category 2 points cannot. Therefore, it is VERY important that you open your GIEH application prior to your international/intercultural experience.

- Anti-Oppressive Practice Workshop (10 points)
- Gender Norms and Sexual Violence Face-to-Face Workshop (10 points)
- Critical and Ethical Global Engagement Face-to-Face Workshop (10 points)
- Western Post-Experience Workshop (10 points)
- Attend five International Week events, getting your 'passport' stamped at each (10 points)
- Exploring Culture and Intercultural Competence Virtual Workshop (10 points)

4. Language Proficiency and Learning – Optional

- This category will accept learning acquired outside of Western Law.
- 10 points for each Western half year language course; 20 points for full year course.
- Students may claim 20 points per language; maximum of 40 points in total.
- Provide transcripts for completion of other language courses taken outside of Western:
 - Proof of graduation from French Immersion secondary school.
 - If previously lived abroad, a Certificate of English proficiency used when first applying to programs in Canada.
- Acquire a second language through other means, including but not limited to, students whose first language is not English; 20 points. Other ways to prove fluency in another language may be possible; contact <u>Western International</u> directly at <u>goabroad@uwo.ca</u>.

Application Process:

Step 1: Enrol in the Global & Intercultural Engagement Honour by completing an application in <u>Atlas</u>, Western's international experience portal. Click on the 'log in to apply' button at the bottom of the program page when you are ready to begin your application.

• **NOTE:** This step *must* be completed <u>before</u> you accumulate any points for Category 2.

Step 2: Complete the "Foundations for Intercultural Competence & Global Engagement" online module. You can access the module on <u>OWL - Western's online learning platform</u> by joining the "Global Learning and Education" site. This module must be completed during the same term you submit your application.

Step 3: Submit completion evidence for:

- Foundations for Intercultural Competence & Global Engagement Online module
- Self-assessment (core competencies)

Following your submission, your application will be reviewed and if approved you will be able to move to Step 4.

Step 4: In <u>Atlas</u>, **submit** evidence of completion for all **category requirements**, where applicable.

Step 5: Upon completion of all Category requirements, write a critical reflection.
