





# Collections Corner: Map & Data Centre

The Map & Data Centre (located within The DB Weldon Library) had its official opening on July 10, 2014. Both the Map Library and the Data Centre were previously part of the Faculty of Social Sciences but joined Western Libraries in 2009. The Map & Data Centre provides map, data, and GIS (Geographic Information System) services to Western students, staff and faculty.

# Data Library

Vince Gray, Data Librarian, passed on some examples of the kinds of data sources that he feels would be of interest to legal researchers:

- •Canadian General Social Surveys on Victimization sample data on the number of people who have been victims of crime, how many have a fear of going out at night, have neighbourhood conflicts, etc.
- •Data from Juristat on drinking and driving or substance abuse, which have been published as surveys such as the *Drinking and Driving Survey*, and the *Alcohol and Other Drugs Survey*.
- Data on demographic characteristics of certain areas

# Map Library

The map collection of the Serge A. Sauer Map Library, includes historic and current sheet maps and atlases, fire insurance plans for Canadian cities and towns, and air photos with a special emphasis on southwestern Ontario.

Cheryl Woods, Map Librarian, also made some suggestions as to what might interest legal researchers: Old maps and air photos for London property searches and for rural property outside of London. Material that is out of copyright can be found on the map library website. Another area of interest for lawyers is the collection of old fire insurance plans for London. The map library also makes available for researchers geospatial data for London, which has been licensed from the City.

Map and Data Centre staff are available for assistance with locating data, and working with data and GIS. In addition, the Map and Data Centre offers GIS-related workshops and events.




