DANCAP PRIVATE EQUITY CHAIR IN CORPORATE GOVERNANCE

The DAN Department of Management & Organizational Studies and the Faculty of Law at Western University invite applications for the Dancap Private Equity Chair in Corporate Governance. This joint appointment is intended to enhance interdisciplinary scholarship and teaching and to solidify Western's position as a leader in the fields of law and management.

The successful applicant will be appointed to a tenured position at the rank of Associate Professor or Professor, or to a Limited Term position (renewal possible), where appropriate. Rank will be commensurate with the candidate's qualifications and experience. Appointment to the Chair will be for a five-year period, renewable. The anticipated start date for the appointment will be July 1, 2019, although alternative start dates may be negotiated.

The holder of this Chair will have a proven research record in the field of corporate governance from both management and legal perspectives. This includes domestic, comparative and international approaches to the regulation of the rights, obligations and relationships among corporate stakeholders; evaluation of the extent to which different governance structures facilitate the financial and other goals of the corporation; the role of markets and government regulators; and the availability of legal recourse against corporate officers and directors by both internal and external stakeholders.

The Chair's research and teaching will complement the academic strengths of both Law and DAN Management & Organizational Studies. Western Law has a longstanding record of strength in business law, particularly in the fields of securities regulation, corporate finance, mergers and acquisitions, and insolvency. In turn, the DAN Department of Management & Organizational Studies seeks to build research clusters and teaching expertise in its unique signature areas, which include Corporate Governance, and new undergraduate programs in Management and Legal Studies.

The candidate will hold a JD, LLB or equivalent degree along with a PhD or advanced graduate degree in law or business, or equivalent experience as a legal or business professional. The nominee must be engaged in an original, innovative program of research, which has the potential to attract excellent graduate students. Demonstrated ability in teaching is an asset, as the successful candidate will be expected to contribute to teaching at the graduate and undergraduate levels within both DAN Management and Law. In addition, the candidate should have the ability and willingness to contribute to the intellectual and scholarly life of both Faculties and to the University more generally.
