In addition, participating in projects such as supporting Ukrainian partners in their efforts to combat gender-based violence deepened my understanding of the connection between domestic and international legal frameworks. As I reflect on these unique experiences, I recognize that my time with the WIGJ has ignited a passion for gender justice advocacy within the international legal framework. Equipped with new skills, insights, and a broader perspective, I am determined to contribute to the pursuit of gender equality and justice in my future legal endeavours. My journey with the WIGJ has not only enriched my understanding of international law but has also solidified my commitment to creating more just and equitable environments.

Debwewin Summer Law Internship - Liying (Coco) Xu



Debwewin Summer Law Internship - Ritika Gupta

This summer I was a Debwewin Intern with the Ontario Federation of Indigenous Friendship Centres. The OFIFC is a non-profit organization that supports and advocates for Friendship Centres across Ontario. Friendship Centres are nongovernment organizations that provide programs and services to Indigenous peoples living in urban areas. I was a part of the Justice team. I conducted academic and legal research on topics pertaining to Indigenous peoples' experiences in the justice system. Topics I touched on included human rights law, the purpose and application of Gladue factors, and the ongoing issue of human trafficking. I also prepared and presented two Public Legal Education seminars for my colleagues and Friendship Centre staff members. One of the highlights of my summer was partaking in the organization's cultural events. For example, I was honoured to join a Summer Feast where I witnessed a Pipe Ceremony, received teachings



from Elders, and shared a meal with my team members. I thoroughly enjoyed my time as a Debwewin Intern. I learned a lot about the challenges Indigenous peoples experience in the justice system, and the positive impact that grassroots-level advocacy and programming can have. Moreover, everyone at the OFIFC was very welcoming, and made sure I felt like a part of the team. I am very grateful to have had this opportunity. Justice for Children and Youth (JFCY) - Molly Gangbar



This summer I had the opportunity of interning with Justice for Children and Youth (JFCY). JFCY is a nonprofit legal aid clinic dedicated to providing legal information, advocacy, and representation to youth under 18 and homeless youth under 25 across Ontario. During my time as a summer intern at JFCY, my responsibilities included facilitating client intake calls, maintaining ongoing client communications, drafting legal documents for clients and test cases, conducting legal research, initiating investigative legal work, reviewing, and summarizing police reports, composing legal memorandums, examining legal factums, and attending court proceedings across various locations in Ontario. During these experiences, I had the privilege of working

with a highly esteemed team of litigators, allowing me to hone my legal research, writing, advocacy, and analytical skills.

One unique experience during my time at JFCY involved being tasked with conducting extensive research to compose a legal memorandum for a high-profile legal case. This memorandum served as foundational research for the JFCY factum submitted to the Ontario Superior Court of Justice, and I was fortunate enough to witness its presentation in court! Through this opportunity, I experienced each stage of the court process,

Another interesting experience at JFCY was when being placed on a JFCY team following a prolonged criminal trial. My role was to attend all trial proceedings at the Ontario Court of Justice and was responsible for taking accurate trial notes. In this position, I learned to adapt to changing court settings, operated with uncertainty, and balanced the demands to communicate to both the JFCY legal team and our client.

Overall, working with JFCY was a privilege, and I recommend this internship to students passionate about youth legal justice. I'm grateful to JFCY and WLIP for providing me this memorable and enriching experience!

Canadian Environmental Law Association (CELA) - Mathie Smith
